Dear Senators McConnell and Schumer,

AGree's [Conservation and Crop Insurance Task Force](#) (Task Force) supports passage of the Agriculture Improvement Act of 2018, S. 3042. We applaud the U.S. Senate Committee on Agriculture, Nutrition and Forestry for voting out of committee this strong legislation.

The bill includes important provisions that will harness the power of agricultural data to provide farmers and policymakers with insights into the impacts of conservation practices on farm and ranch profitability, yield variability, and risk while protecting producer privacy. The bill also provides clear, unambiguous federal rules establishing all conservation practices as legitimate for crop insurance purposes and establishes a process for crop insurance premium discounts on risk-reducing conservation practices.

S. 3042 will remove roadblocks for farmers who want to implement practices that improve soil health and water quality and reduce risk on their land. Improved data management systems and federal guidance on conservation practices will give farmers the information they need to make important land management decisions.

We commend Chairman Roberts, Ranking Member Stabenow, and the rest of the committee for their hard work to craft a bipartisan farm bill, and applaud Senators Klobuchar, Thune, and Donnelly for their leadership on behalf of producers and the environment. We urge the U.S. Senate to retain these important provisions as the bill is debated on the Senate floor.

The Task Force is committed to working with members of Congress in both chambers to pass a farm bill that enhances our federal risk management programs by recognizing and strengthening the link between conservation and crop insurance.
